OVERVIEW

I am a leading social scientist, cross-national survey methodologist and Director of one the largest pan-European social research infrastructures. I combine academic rigour with a passion for social research which complements my entrepreneurial skills.

I currently direct the European Social Survey (ESS) European Research Infrastructure Consortium (ESS ERIC), a world leading cross-national survey research infrastructure. As Director I am the chief executive officer, chief scientific officer and legal representative of ESS ERIC (www.europeansocialsurvey.org). The infrastructure has serviced over 200,000 data users from around the world, has had significant academic and teaching impact and its findings have directly influenced both policy and society. There are almost 5000 publications to date using ESS data, I established the ERIC in late 2013 with 14 Member governments in Europe and have seen that increase to 28 members by 2022. The ESS ERIC has a core annual budget of €2.6 Million and an associated spend on national costs of around €4 million per annum. I manage the ESS ERIC through a team of staff in London, through 6 other research institutes across Europe and via the National Coordinators and survey institutes in each of the 28 or more participating countries in each biennial survey round.

I have published in leading publications in the field, attracted millions of Euro in research funding and have demonstrated successful leadership at both the national and international level. I coordinated the €8.4 Synergies for Europe's Research Infrastructure in the Social Sciences (SERISS) project undertaking cutting edge methodological research in cross-national survey methodology and drawing together research infrastructures from across the social sciences (www.seriss.eu). SERISS included a 'proof of concept' for the first ever *cross-national* probability-based web panel. I am currently coordinating the ESS SUSTAIN-2 h2020 grant a €5 Million award to prepare ESS methods for the future.

In 2016 I was awarded my PhD 'Striving for quality, comparability and transparency in cross-national social survey measurement: illustrations from the European Social Survey' supervised by Dr Tom Smith from NORC, Chicago. My PhD showed how I had applied the Total Survey Error paradigm from an academic and practical perspective to identify and reduce survey error.
